The margin on top should be 2.54 cm, left, right and bottom are 0.50 cm. All the content should be in Time New roman, 11 font size, single space, justified. Tables and figures should be place in center. This section should briefly outline the background of the research problem and provide a critique of relevant literature, cited according to Vancouver style. It should identify gaps in existing research, propose a solution, and clearly articulate the study's objectives, hypotheses, and its original contribution to the theoretical body of knowledge. Additionally, the practical significance of the study should be outlined. The literature review serves to summarize, evaluate, and compare key developments and ongoing debates relevant to the research topic. It identifies gaps in current knowledge and evaluates existing solutions, establishing a framework against which the study's contributions can be assessed. It is essential that the review incorporates the most recent and pertinent literature in the field. (References should be cited as superscripted numerals following punctuation, for example, ^[1])

II. METHODOLOGY/ DESIGN OF STUDY

This section should describe and justify the chosen methods, including the study setting, sample size, and selection method. A brief description (2-3 sentences) of the demographic characteristics of the sample should be provided. It should also detail the study design, data collection tools, ethical approval, and methods used to ensure privacy and confidentiality. If applicable, include any pilot study and modifications made. Statistical analysis and tests should be described. Citations should be limited to data sources and references where additional details of the research procedures can be found, using superscripted numerals (e.g., ^[1]).

III.RESULTS/ FINDINGS

The results section should present the observed data, including statistics, tables, and graphs, in a logical and concise manner. Both positive and negative results should be included, and only essential data necessary for understanding the conclusions should be presented. Tables and figures should not be repeated in the text, and the same data should not be shown in both tabular and graphic forms. Tables and figures should be not more than 5 numbers. Key findings should be stated clearly, but detailed interpretation of the data should be reserved for the discussion section.

IV.DISCUSSION

The discussion should focus on the interpretation of results, without reiterating the findings presented in the Results section. This section should contextualize new findings in relation to existing literature and theoretical frameworks, providing logical deductions and implications of the study's outcomes. It should also critically address the limitations of the study and propose directions for future research. Recommendations may be included where appropriate and relevant to the study's context.

V. SUMMARY AND CONCLUSION

The conclusion should begin with a concise summary of the key findings, linking them to the study's objectives. Avoid unqualified statements and ensure conclusions are fully supported by the data. The conclusion should provide answers or solutions to the research questions posed in the introduction and highlight the study's broader implications. **Recommendations** for future research can be included where appropriate, emphasizing areas that warrant further exploration.
